

# The David Beckham Academy Match Master Games Sweepstakes

## Official Rules

NO PURCHASE NECESSARY. A PURCHASE OF ANY KIND WILL NOT INCREASE YOUR CHANCES OF WINNING. MANY WILL ENTER, FEW WILL WIN. OPEN ONLY TO LEGAL RESIDENTS OF THE FIFTY STATES OF THE UNITED STATES OF AMERICA AND THE DISTRICT OF COLUMBIA WHO ARE AT LEAST EIGHT (8) YEARS OF AGE OR OLDER AT THE TIME OF ENTRY. PROOF OF AGE REQUIRED. VERIFIABLE PARENT'S OR LEGAL GUARDIAN'S CONSENT IS REQUIRED IN ORDER FOR A CHILD UNDER 13 YEARS OF AGE TO ENTER OR WIN A PRIZE. VOID WHERE PROHIBITED BY LAW.

**1. Eligibility.** The David Beckham Academy Match Master Games Sweepstakes (the "Sweepstakes") is open only to legal residents of the fifty (50) states of the United States of America and the District of Columbia who are at least eight (8) years of age or older ("Entrant") at the time of entry.

**Special Instructions for Children Under 13 Years of Age:** Entrants under 13 years of age must have the verifiable consent of his/her parent/legal guardian to enter the Sweepstakes and will be required to provide the first and last name of his/her parent/legal guardian and the email address of his/her parent/legal guardian before entering the Sweepstakes. Please see the Parent/Legal Guardian Verifiable Consent section, below, for the rules for obtaining parent/legal guardian verifiable consent.

**Parent/Legal Guardian Verifiable Consent:** An email will be sent to the parent/legal guardian's email address that the child has provided upon his/her request to enter the Sweepstakes. The parent/legal guardian of the child Entrant will be sent an email (the "Consent Email") and given the opportunity to consent to his/her child's entry in the Sweepstakes at any time during the Sweepstakes Period (see Timing, Section 4 for the Sweepstakes Period) by completing the Participant Registration Form (via link provided in the Consent Email). The Participant Registration Form will request a minimum of the following of the parent/legal guardian: first and last name of the child Entrant, address (no PO Boxes), city, state, zip code, birth date and daytime telephone number. A child under the age of 13 will not be considered an Entrant and will not be eligible to participate in the Sweepstakes unless: (1) the parent/legal guardian completes the Participant Registration Form; (2) the parent/legal guardian emails the Participant Registration Form to Sponsor and/or Administrator; and (3) Sponsor and/or Administrator receives a "delivery sent" confirmation that a verification email sent from Administrator (the "Verification") to the parent/legal guardian sending in the Consent Email, was actually received by the email address provided by the parent/legal guardian (see Section 2 and 3 below for the identity of Sponsor and Administrator). If the parent/legal guardian does not email the completed Participant Registration Form within two weeks after the Consent Email is sent by Administrator, the child's information will be deleted from the Sweepstakes database. The parent/legal guardian may also prohibit the child from entering the Sweepstakes and request to have the child's information deleted from the Sweepstakes database by notifying Sponsor and/or Administrator by email. A parent/legal guardian of child Entrant who has questions regarding the use of the Entrant's personal information should review the Privacy Policy of Sponsor at [www.MatchMasterSweepstakes.com](http://www.MatchMasterSweepstakes.com). Upon parent/legal guardian completion of the Participant Registration Form and Sponsor/Administrator's verification, the child under 13 will be an Entrant and can participate in the Sweepstakes during the Sweepstakes Period according to the terms and conditions contained in these Official Rules.

**Special Instructions for Children 13 Years of Age and Older:** All persons that are 13 years of age or older at the time of entry, but are under the age of majority in their jurisdiction of residence, must obtain a parent/legal guardian's consent before participating in the Sweepstakes. By registering to enter the Sweepstakes, each such Entrant agrees and represents that he/she has asked his/her parent/legal guardian for permission to enter the Sweepstakes and such parent/legal guardian has given permission for him/her to enter the Sweepstakes.

**Other Restrictions on Eligibility.** Employees of the following entities, and the immediate family (spouse, parents, siblings and children) and household members of each such employee, are not eligible to enter the Sweepstakes: Match Master Games, Ltd., The David Beckham Academy, Fox Rothschild LLP, The A Team LLC and their parent and affiliate companies. Participation in the Sweepstakes is subject to all applicable federal, state and local laws and regulations. Void where prohibited by law. Participation constitutes an Entrant's (or the parent/legal guardian's) full and unconditional agreement to these Official Rules and Sponsor's and/or

Administrator's decisions, which are final and binding in all matters related to the Sweepstakes. Winning a prize is contingent upon fulfilling all requirements set forth herein.

**4. Timing.** The Sweepstakes shall run from 12:01 a.m. EST on June 1, 2008 to 11:59 p.m. EST on September 1, 2008 (the "Sweepstakes Period"). Administrator's computer is the official time keeping device for this Sweepstakes.

**5. How to Enter.** No purchase necessary. You must have Internet access during the Sweepstakes Period to enter the Sweepstakes. Enter online in one of two ways.

**Match Master Game method:** A 12 digit code is located on the inside of the MatchMaster Interactive Soccer Game (the "Game"). This code can be used to enter the Sweepstakes one time during the Sweepstakes Period. Go to The David Beckham Academy website located at <http://www.thedavidbeckhamacademy.com> (the "Website"). The Entrant must choose the "United States, Los Angeles" location and click on the "Sweepstakes" sub-tab to be directed to the Sweepstakes url, [www.MatchMasterSweepstakes.com](http://www.MatchMasterSweepstakes.com). An Entrant will enter his/her birth date and click "Submit". An Entrant 13 years of age or older at the time of entry will then be requested to submit the 12 digit code found inside the Game and to complete and submit all other required information requested in the Participant Registration Form. An Entrant under the age of 13 will be required to submit his/her parent/legal guardian's name and email address (see Special Instructions for Children Under 13 Years of Age, Section 1 above) before entering the Sweepstakes.

**Non-purchase method:** During the Sweepstakes Period, a person may visit The David Beckham Academy website located at <http://www.thedavidbeckhamacademy.com> (the "Website"). The Entrant must choose the "United States, Los Angeles" location and click on the "Sweepstakes" sub-tab to be directed to the Sweepstakes url, [www.MatchMasterSweepstakes.com](http://www.MatchMasterSweepstakes.com). An Entrant will enter his/her birth date and click "Submit". An Entrant 13 years of age or older at the time of entry may then request a 12 digit code. A 12 digit code will be generated and the Entrant will then be requested to submit the 12 digit code and to complete and submit all other required information requested in the Participant Registration Form. An Entrant under the age of 13 will be required to submit his/her parent/legal guardian's name and email address (see Special Instructions for Children Under 13 Years of Age, Section 1 above) before entering the Sweepstakes.

**6. Limit:** An Entrant may enter the Sweepstakes via the Website one (1) time each calendar day. An Entrant may use only one (1) email address per person. Entry must be made by the Entrant only through the Website. Entries that are not made by the Entrant through the Website, whether the entry is made by an individual, entity, and/or originating at any other website or email address, including but not limited to commercial sweepstakes subscription notification and/or entering service sites, will be declared invalid and disqualified for the Sweepstakes. The use of any automatic access device, including but not limited to scrapers, robots and spiders, to automate the entry process is prohibited. Only eligible entries received during the Sweepstakes Period will be accepted. All entries shall become the property of Sponsor.

**7. Potential Winner Selection:** On September 15, 2008, the potential winner(s) of each Prize (see Section 9 for description of Prizes) will be randomly selected from all eligible entries under the supervision of Sponsor and/or Administrator whose decisions as to the operation of the Sweepstakes and the selection of potential winners are final and binding in all matters related to the Sweepstakes. Proof of submission of the Participant Registration Form does not constitute proof of eligibility or receipt of the Participant Registration Form by Sponsor and/or Administrator. Sponsor and/or Administrator will randomly select one (1) potential winner for each of the Grand, First and Fourth Place Prizes, ten (10) potential winners for each of the Second and Third Place Prizes, twenty (20) potential winners

for the Fifth Place Prize and two hundred (200) potential winners for the Sixth Place Prize. Sponsor will not award a greater number of prizes than are stated in these Official Rules.

**8. Verification of Potential Winners.** To win a Prize, potential winners must continue to comply with all terms and conditions of these Official Rules. The potential winners will be notified by email approximately three (3) calendar days following selection of each potential winner (the “Notification Email”). ***In order to claim the Grand Prize, or the First, Second, Third or Fourth Place Prizes, a potential winner (or the parent/legal guardian of the potential winner who is under the age of majority in his/her state of residence) must provide proof that he/she is the authorized account holder of the email address associated with the potentially winning entry, and will be required to sign and return to Sponsor and/or Administrator an Affidavit of Eligibility/Liability & Publicity Release (“Affirmation”) within fourteen (14) calendar days of the date the Notification Email is sent or is attempted to be sent.*** The Affirmation will also require the potential winner, the parent/legal guardian of the potential winner and all guests to send to Sponsor a photocopy of the first page of their respective passports in order to claim the Grand Prize. The Affirmation will grant to Sponsor the right to use and publish the person’s full name and likeness, online and in print or any other media, for advertising and promotion purposes worldwide, without additional compensation unless prohibited by law, and will contain appropriate medical releases and The David Beckham Academy’s standard attendee’s release form for any guest attending The David Beckham Academy course. All materials submitted by a potential winner and his/her guest and any parent/legal guardian become the property of Sponsor and will not be returned. If a potential winner cannot be contacted via email, or fails to sign and return the Affirmation within the specified time period after the Notification Email has been sent or attempted to be sent, the potential winner will be disqualified and will forfeit the Prize. Sponsor and/or Administrator are not responsible for any incorrect or inaccurate Entrant information, whether caused by human error, natural disaster, data transmission or any other means, and are not responsible for contacting any Entrant by any means except via email. If the Entrant has changed contact information or email address since completing and submitting the Participant Registration Form, or if the Entrant does not receive the Notification Email for any reason, Sponsor and/or Administrator are not responsible for contacting the Entrant.

In the event that a potential winner does not return the Affirmation in the specified time period or is disqualified for any reason, Sponsor and/or Administrator may award the applicable Prize to an alternate winner, by a random drawing from among all remaining eligible entries who have not already be selected to win any Prize.

Upon the receipt and approval by Sponsor and/or Administrator of the potential winner’s Affirmation, the potential winner will be notified that he/she is an actual winner (“Winner”). The Winner also will receive further instructions for the redemption of his/her Prize.

**9. Prizes.** An Entrant is eligible to receive one of the following prizes (each a “Prize”):

The Winner may select up to four (4) friends<sup>e</sup> to accompany him/her. A parent/legal guardian must accompany the Winner and each friend.<sup>c</sup> The Grand Prize includes Round Trip Airfare<sup>b</sup> for up to ten (10) people to London; five

consecutive (5) nights for up to ten (10) people at a hotel<sup>d</sup> to be selected by Sponsor; transfers to and from the airport and hotel and to and from the hotel and The David Beckham Academy. Approximate retail value for this Prize package is \$35,000. **Odds of winning:** One (1) Grand Prize for all entries received. Sponsor and/or Administrator are unable to determine the number of entries.

**One (1) First Place Prize – Los Angeles Experience.** This Prize shall only be awarded to a child who is 8–11 years of age at the time of entry.<sup>a</sup> One (1) Winner will attend a Three-Day David Beckham Academy Course in Los Angeles. Winner’s soccer team may accompany the Winner, which team can be a maximum of seventeen (17) people, which shall include the Winner and the Winner’s parent/legal guardian, two other adults (who should be the coaches of Winner) and fourteen members of Winner’s soccer team or other friends<sup>c</sup> (the “Team”).<sup>c</sup> The First Place Prize includes Round Trip Airfare<sup>b</sup> for the Team to Los Angeles; three (3) consecutive nights for the Team at a hotel<sup>d</sup> to be selected by Sponsor; transfers to and from the airport and the hotel and to and from the hotel and The David Beckham Academy. Approximate retail value for this Prize package is \$35,000. **Odds of winning:** One (1) First Place Prize for all entries received. Sponsor and/or Administrator are unable to determine the number of entries.

**Ten (10) Second Place Prizes.** This Prize shall only be awarded to children who are 12–15 years of age at the time of entry.<sup>a</sup> Ten (10) Winners will attend a Five-Day David Beckham Academy Course in Los Angeles. A parent/legal guardian must accompany each Winner.<sup>c</sup> The Second Place Prize includes Round Trip Airfare<sup>b</sup> for up to two (2) people to Los Angeles; five (5) consecutive nights for up to two (2) people at a hotel<sup>d</sup> to be selected by Sponsor; transfers to and from the airport and the hotel and to and from the hotel and The David Beckham Academy. Approximate retail value is \$3,500 for each Prize package. **Odds of winning:** Ten (10) Second Place Prizes for all entries received. Sponsor and/or Administrator are unable to determine the number of entries.

**Ten (10) Third Place Prizes:** This Prize shall only be awarded to children who are 8–11 years of age at the time entry.<sup>a</sup> Ten (10) Winners will attend a Three-Day David Beckham Academy Course in Los Angeles. A parent/legal guardian must accompany each Winner.<sup>c</sup> The Third Place Prize includes Round Trip Airfare<sup>b</sup> for up to two (2) people to Los Angeles; five (5) consecutive nights for up to two (2) people at a hotel<sup>d</sup> to be selected by Sponsor; transfers to and from the airport and hotel and to and from the hotel and The David Beckham Academy. Approximate retail value is \$3,000 for each Prize package. **Odds of winning:** Ten (10) Prizes for all entries received. Sponsor and/or Administrator are unable to determine the number of entries.

**One (1) Fourth Place Prize.** This Prize shall only be awarded to a child who is 8–15 years of age at the time entry.<sup>a</sup> One (1) Winner will receive instruction from two (2) The David Beckham Academy coaches at the Winner’s home training field. The Winner and up to nineteen (19) additional friends who are also between the ages of 8 and 15, will receive six (6) hours of soccer instruction at the Winner’s home training field and receive a David Beckham Academy jersey. Winner shall provide balls, cones, bibs, goals and field. Approximate retail value for this Prize package is \$3,500. **Odds of winning:** One (1) Prize for all entries received. Sponsor and/or Administrator are unable to determine the number of entries.

be accompanied by a parent/legal guardian, and is also permitted to bring his/her Team to Los Angeles (see First Place Prize description for the definition of “Team”). A Team member under the age of majority in his/her jurisdiction of residence (the “Under Age Guest”) must obtain his/her parent/legal guardian’s written permission, which writing must be presented to Sponsor before any airplane and hotel reservation can be made. Sponsor may, but is not obligated to, contact the Under Age Guest’s parent/legal guardian to confirm such permission; if Sponsor does contact an Under Age Guest’s parent/legal guardian and such permission cannot be immediately confirmed, such Under Age Guest will not be allowed to accompany the Winner.

<sup>c</sup>Friends who accompany a Winner and are within the same age group as the Winner may attend The David Beckham Academy Soccer Course.

**Twenty (20) Fifth Place Prizes:** Twenty (20) Winners will receive a David Beckham Academy soccer kit and sweatshirt. Approximate retail value is \$150 for each Prize. **Odds of winning:** Twenty (20) Prizes for all entries received. Sponsor and/or Administrator are unable to determine the number of entries.

**Two Hundred (200) Sixth Place Prizes:** Two Hundred (200) Winners will receive a David Beckham Academy “goody” bag, which consists of a skills book, mug, pens and pencils, and key-ring. Approximate retail value is \$40 for each Prize. **Odds of winning:** Two Hundred (200) Prizes for all entries received. Sponsor and/or Administrator are unable to determine the number of entries.

**APPROXIMATE TOTAL VALUE OF ALL PRIZES: \$149,500.00.**

**10. Redemption of certain Prizes.** The Winners of the Grand Prize, and the First, Second and Third Place Prizes, must redeem the Prize during the month of July in 2009 (the “July Redemption Date”). The Winner of the Fourth Place Prize must redeem the Prize between February 1, 2009 and July 30, 2009 (the “Spring – Summer Redemption Date”). All Winners, guests, Team members, Winner’s coaches and parent/legal guardians must confirm all travel arrangements with the Administrator/Sponsor by June 1, 2009, for the Grand Prize and the First, Second and Third Place Prizes and by February 1, 2009 for the Fourth Place Prize. A Winner (or parent/legal guardian) who has accepted the Grand Prize, or the First, Second or Third Place Prizes, but who does not confirm with the Administrator/Sponsor that he/she has completed making all travel arrangements (including travel arrangements for guests, parents/legal guardians of guests, Team members and/or Winner’s coaches) by June 1, 2009, shall automatically forfeit the respective Prize in its entirety without any compensation, and Sponsor shall have no further obligation to the Winner. A Winner who has accepted the Fourth Place Prize but who does not confirm the travel dates of The David Beckham Academy coaches thirty (30) days before the February 1, 2009, shall automatically forfeit the Prize in its entirety without any compensation, and Sponsor shall have no further obligation to the Winner.

**11. Limitations of Prizes.** Limit one (1) Prize per person. Flights and hotel accommodations are subject to availability and are non-transferable. No refunds or credit changes are allowed. All tickets are subject to flight and hotel variation, work stoppages, and schedule or route changes. All travel and hotel arrangements must be made through Sponsor’s travel agent, who will contact Winner after receipt and approval of the Affirmation. All expenses not listed in the Prize Section (Section 9), including without limitation tips, entertainment, room service, and all ground transportation not specifically listed in Section 9, are the responsibility of the Winner and his/her guests (or the Winner’s parent/legal guardian).

No cash or other substitution is permitted, except as provided herein at Sponsor’s sole discretion or if required by law. Each Prize is nontransferable, unless otherwise specifically approved by Sponsor in writing. Sponsor reserves the right to substitute any listed Prize for one of equal or greater value if the designated Prize should become unavailable for any reason. Except as specifically included in the Prize description, the Winner or his/her parent/legal guardian is responsible for all applicable taxes and fees associated with Prize receipt and/or use, including but not limited to income taxes and additional costs.

**12. Conditions of Participation.** Each Entrant and each parent/legal guardian of any Entrant under the age of majority in his/her respective jurisdiction of residence agrees to: (1) be bound by all applicable United States of America federal, state and local laws and regulations, by the terms and conditions of these Official Rules, and the decisions of Sponsor and/or Administrator, which are final and binding on all matters relating to the Sweepstakes; (2) to waive any right to claim ambiguity in the Official Rules; and (3) to release, indemnify and hold harmless Sponsor, Administrator, and their respective subsidiaries, affiliates, suppliers, distributors, agents, advisors, representatives, advertising agencies and each of their respective parent companies and each such company’s officers, directors, employees and agents (collectively, the “Released Parties”) from and against any claim or cause of action, including, but not limited to, personal injury, death, or damage to or loss of property, arising out of participation in the Sweepstakes or receipt or use or misuse of any Prize. Sponsor reserves the right to cancel, suspend and/or modify the Sweepstakes, or any part of it, if any fraud, technical failures or any other factor beyond Sponsor’s and/or Administrator’s reasonable control impairs the integrity or proper functioning of the Sweepstakes, as determined by Sponsor in its sole discretion. In such event, Sponsor reserves the right to award the Prizes at random from among the eligible entries received up to the time of the impairment. *Sponsor reserves the right, in its*

*sole discretion, to disqualify any individual it finds to be tampering with the Website, the entry process, or the operation of the Sweepstakes or to be acting in violation of these Official Rules or in an unsportsmanlike or disruptive manner.* Any attempt by any person to deliberately undermine the legitimate operation of the Sweepstakes may be a violation of criminal and civil law, and, should such an attempt be made, Sponsor reserves the right to seek damages from any such person to the fullest extent permitted by law. Sponsor's failure to enforce any term of these Official Rules shall not constitute a waiver of that provision.

**13. Disclaimer and Limitation of Liability.** THE RELEASED PARTIES ARE NOT RESPONSIBLE FOR: (1) ERROR, OMISSION, INTERRUPTION, DELETION, DEFECT, DELAY IN OPERATION OR TRANSMISSION, COMMUNICATIONS LINE FAILURE, THEFT OR DESTRUCTION OR UNAUTHORIZED ACCESS TO, OR ALTERATION OF ENTRIES; (2) TECHNICAL FAILURES OF ANY KIND, INCLUDING, BUT NOT LIMITED TO MALFUNCTIONS, INTERRUPTIONS, OR DISCONNECTIONS IN PHONE LINES OR TELEPHONE NETWORKS, NETWORK HARDWARE OR SOFTWARE, SERVERS, PROVIDERS, COMPUTER EQUIPMENT FAILURE, TRAFFIC CONGESTION ON THE INTERNET OR THE WEBSITE OR THE FAILURE OF ANY EMAIL OR ENTRY TO BE RECEIVED BY SPONSOR AND/OR ADMINISTRATOR OR ANY COMBINATION OF THE ABOVE; (3) UNAUTHORIZED HUMAN INTERVENTION IN ANY PART OF THE ENTRY PROCESS OF THE SWEEPSTAKES; (4) TECHNICAL OR HUMAN ERROR WHICH MAY OCCUR IN THE SUBMISSION OF AN ENTRANT'S PARTICIPANT REGISTRATION FORM, THE ADMINISTRATION OF THE SWEEPSTAKES OR THE PROCESSING OF ENTRIES; OR (5) ANY INJURY OR DAMAGE TO PERSONS OR PROPERTY WHICH MAY BE CAUSED, DIRECTLY OR INDIRECTLY, IN WHOLE OR IN PART, FROM AN ENTRANT'S PARTICIPATION IN THE SWEEPSTAKES, DOWNLOADING ANY MATERIALS FROM THE WEBSITE, OR RECEIPT OR USE OR MISUSE OF ANY PRIZE.

**14. Privacy and Use of Sweepstakes Information.** Any personal information received by Sponsor and/or Administrator in connection with this Sweepstakes will be used solely in accordance with Sponsor's Privacy Policy, located at [www.MatchMasterSweepstakes.com](http://www.MatchMasterSweepstakes.com) (the "Privacy Policy") which allows the Entrant, or the Entrant's parent/legal guardian, to easily change contact preferences. Information collected from the Entrant is used only for the purposes disclosed in the Privacy Policy and will be shared with The David Beckham Academy if the Entrant, or the parent/legal guardian of an Entrant under the age of 13, has opted-in to receive additional information and/or promotional information from Sponsor and/or The David Beckham Academy at the time of entry. All information received by Sponsor and/or Administrator shall become the property of Sponsor and will not be returned.

**15. Governing Law and Forum Selection.** These Official Rules and this Sweepstakes are governed by and controlled by the laws of State of Delaware, applicable to contracts made and performed therein without reference to the applicable choice of law provisions. All actions, proceedings or litigation relating hereto will be instituted and prosecuted solely within the State of Delaware.
